A. OBJECTIVE & SCOPE OF WORK

The Primary objective of this work is for making vertical garden green and lights operational 24 x 7 in Ranchi City by providing better quality support for repair and maintenance to vertical garden with a view that it enhances the beauty of city. This includes:-

- ✓ Maintain a Regular watering of plants
- ✓ Prevent failure of LEDs
- ✓ Checking & correction of controller components, LED Light driver, switches, contacts, terminals, timers and fault Log
- ✓ Detection of cable faults
- ✓ Replacement of plants as per requirement
- ✓ Replacement of plastic pot as per requirement
- ✓ Repair of acrylic letter LED light board
- ✓ Fertilizer for plants
- ✓ Disease and pest control of plants
- ✓ Maintain a Regular Pruning Schedule.
- ✓ Gps photographs of maintenance work

Operational maintenance: This type of maintenance is the periodic scheduled (every day) operational maintenance to minimize existing and future problems. This maintenance includes the watering of plants, replacement of dead plants, detection of cable faults, repair of LED light and acrylic letter board light and other activities like regular pruning of plants.

Third Party Damage: In case of any damage due to accident or any other reason or shifting of lights and its accessories due to any govt. activity, if there will be any requirement of replacing any major parts restricted to (a) Plastic Pot (100/150 mm) (b) LED Light (c) Acrylic letter LED light board 8'0"x 4'0" with all accessories (d) shifting of vertical garden with Civil Work (e) 2 core 6 sqmm cable (f) Pot Stand (3 pot) 1'8" x 0'6" (g) Granite 60 sqft approx (h) Stainless steel Grade-304 dimension 16'0"x 8'0" only the rate of these parts or activities associated with will be paid by RMC explicitly. Other charges will be the part of AMC

The bidder will maintain a team of electrician and gardener personnel to maintain the vertical green wall continuously over contract period.

The response time for emergency maintenance would be 2 hours and for operational maintenance 12 hours.

The quality of spare or new fixture should be same as of the installed fixture or system which will be installed (*if required*) after the verification & approval of competent authority of RMC.



The bidder has to take the responsibility of repair & maintenance of the entire installed vertical green wall up to the project period. The fixture repairing shall be done free of cost for the warranty period. RMC shall not provide any manpower or machinery support for the above task.

B. GENERAL TERMS & CONDITIONS AND ELIGIBLITY CRITERIA

- The sealed packets submitted by post should reach and delivered in the office within the stipulated date and time positively. The department will not be held responsible for any delay or loss or damage of the Bid documents during transit and in such events the bids stands rejected summarily. The sealed cover shall be received in the office of Horticulture, Ranchi Municipal Corporation.
- ii) The tender should be submitted in two envelops i.e.:
 - a: Technical Bid document along with EMD and tender fee
 - b: Price Bid. There should be proper indication of the contents on each envelope.
- The Bidders shall seal the envelope No.1 Technical envelope and envelope No.2 Commercial envelope in separate inner envelopes, duly marking the envelopes as "envelop No.1, Technical Envelope" and "envelope No.2 Commercial Envelope". He shall then place these two envelopes in an outer envelope.
- iv) The **Technical bid** envelope should contain the following:
 - a) Affidavit regarding non blacklisting by any govt/PSU.
 - b) Document related to experience in the business of installation & maintenance of vertical green wall. (Attach experience certificate)
 - c) Documents showing GSTIN, PAN and ESIC registration.
 - d) Details of tender fee and EMD.
 - e) Audited annual balance sheet of last 03 (three) years in support of turnover.
 - f) Mention the technical details in Annexure 01 also.
 - g) Document related to trade license for work must be provided.

v) Commercial bid

- a) The envelop of commercial bid will be open only for those bidder who would qualify in the technical bid. The lowest rate (L1) will be decided on the basis of the total quoted amount.
- b) Rate must be quoted in a attached format provided in Annexure 02.
- c) Prices/rates should be inclusive of all taxes and charges. RMC shall not provide /not bear cost of or any additional items.
- vi) Any bid received by the Tendering Authority after the deadline for submission of bids prescribed by the Tendering Authority, will be rejected and/or returned unopened to the Bidder



- vii) The bidder must be a proprietor, firm, company. JV not allowed.
- viii) Bidders shall have a team of experienced personal who possess good knowledge / Experience of minimum one year for maintenance of vertical green wall. (Attach experience certificate)
- ix) The Bidder should have average annual financial turnover during the last three years (2019-20, 2020-21and 2021-22) should not be less than Rs. 50 Lakhs.
- x) RMC reserves the right to undertake confidential verification of the bid documents received. Discrepancies found, if any, will deal as per the law.
- xi) Rates/Prices to be quoted should be inclusive of all taxes, freight, insurance, charges, etc. Each quantum of payment to be made by RMC to the agency shall be subject to statutory deductions/retention as per relevant practices and rules.
- xii) Tender shall be written in English and the proposal and all the associated documents will be submitted either in English or Hindi language. Documents in other language will not be considered unless and until it's translated version is not submitted with it.
- xiii) The firm should submit valid GST Clearance certificate from the competent authority along with the tender paper.
- xiv) The Municipal Commissioner reserves the right to reject any or all of the tenders without assigning any reasons.
- The successful tenderer shall furnish a performance bank guarantee (BG)/NSC/TD of 05% after the award of work in favor of MC, RMC Ranchi.

 In case of successful bidder EMD shall be converted and adjusted against the security deposit and for unsuccessful bidder the EMD shall be returned after award of the work to the successful bidder.
- xvi) Site Inspection: Bidder(s) are deemed to have got acquainted with the site conditions and also advised to visit the site sufficiently in advance of the date fixed for submission of tender.
- xvii) Before tendering, the bidder shall visit all sites and satisfy himself to the prevalent conditions and quote accordingly.
- xviii) Bidder should have at least one office of their own having their own engineers/technicians in Ranchi.
- xix) Bidder should have to maintain the vertical green wall for two year.
- xx) Bidder should visit site initially which included attributes relevant to location, condition of vertical garden before quoting rate.
- xxi) List of vertical green wall is installed is mentioned in Annexure-03



xxii) No. of vertical green wall mentioned in annexure-03 may increase or decrease.

C. PAYMENT TERMS:

Payment will be done on monthly basis.

During inspection of RMC team if it is found that bidder is not maintaining the plants and lights of vertical green wall properly, RMC will have the authority to hold further payment for those vertical green wall till it is rectified satisfactory.

The rate shall be all inclusive all taxes and any other charges. The payment will be subject to the provisions of the Income Tax Act, 1961 i.e., Tax will be deducted at source with Cess/ Surcharge, at the prevailing rates, from the gross amount of bill submitted.

D. PENALTY

A penalty of 10% of the quoted rate will be imposed for failure to respond during maintenance work.

E. LEGAL DISPUTE AND JURISDICTION OF COURTS

In case any claim, dispute or difference arising in respect of the contract, the cause of action there of shall be deemed to have arisen in Ranchi and all legal proceedings in respect of any such claim, dispute or difference shall be dealt with amicably between the two parties or settled at Ranchi Court Only.
