under JnNURM Scheme**

A2Z Waste Management (Ranchi) Limited (Concessionaire) on behalf of Ranchi Municipal Corporation (RMC) is providing civic services to an estimated population of approximate 1(one) million citizen in the capital city of Jharkhand. The project area covers 55 municipal wards spread over in area of about 175.12 sq. km. As per the Concession Agreement, the Concessionaire has to provide services including door to door collection of MSW, street sweeping, drain cleaning, storage of waste at secondary collection points, transportation of MSW and finally its treatment and disposal at the identified site.

Ranchi Municipal Corporation (RMC) is responsible for providing better sanitation facilities to its citizens. RMC desires to select a **Project Engineer** who shall be responsible to review, monitor, certify the activities undertaken by Concessionaire on daily basis and to approve activities associated with the design, construction, operation & maintenance of the project facilities to ensure compliance by the Concessionaire with construction requirements and O & M requirements.

Chief Executive Officer, RMC invites Request for Proposal (RFP) from eligible parties to undertake the activities mentioned above.

Criteria for short listing of firm is as follows:

The firm will be assessed on the basis of technical criteria mentioned in the RFP. The financial proposal of those firms would be opened only if they qualify in technical proposal. The bidder, who quotes the lowest fees, shall be declared as the selected bidder.
